1. The extent to which and how the funds will be used to implement prevention and mitigation strategies that are to the greatest extent practicable consistent with the most recent CDC guidance on reopening schools in order to continuously and safely open and operate schools for in-person learning; (261 of 2000 maximum characters used)

Funds will be used to create appropriate social distancing measures amongst the students by 1) Creating smaller class sizes through expanded teaching staff, and 2) Creating small class sizes through the creation and utilization of expanded instructional spaces.

2. How the LEA will use the funds it reserves under section 2001(e)(1) of the ARP Act to address the academic impact of lost instructional time through the implementation of evidence-based interventions such as summer learning or summer enrichment extended day comprehensive afterschool programs or extended school year; (618 of 2000 maximum characters used)

RBCS plans to use funds to address academic impact of lost instructional time through summer and before/afterschool programs targeted in areas in need. Summer programs will be offered for students entering the building on foundations of Math, English, and Social-Emotional Learning. Students will be offered intervention summer programs for bridging skill area gaps and enrichment programs to increase content knowledge for at-risk students. Afterschool programs throughout the year will offered for students struggling with courses, enrichment

RBCS has and will continue to utilize its school nurse, as well as outside professional development training, to ensure that all staff and students are practicing the most up-to-date protocols in regards to safe practices and sanitization in order to stop the spread of COVID-19.

4. How the LEA will ensure that the interventions it implements, including but not limited to the interventions implemented under section 2001(e)(1) of the ARP Act to address the academic impact of lost instructional time, will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.
